SUBJECT: AUDITS AND OTHER EXAMINATIONS PERFORMED BY OUTSIDE ENTITIES

POLICY:

The policy of the Department of Human Services (DHS) is to protect, to the greatest extent possible, all resources awarded to and utilized by contractors and grantees in the delivery of services to Agency clients. In addition, as reflected in applicable laws, regulations, agreements, and standards, IA is responsible for providing reliable, useful, and timely information for transparency and accountability of all programs and their operations to Executive Leadership, Legislators, oversight bodies, those charged with governance, and the public need to know whether (1) management and officials manage government resources and use their authority properly and in compliance with laws and regulations; (2) government programs are achieving their objectives and desired outcomes; and (3) government services are provided effectively, efficiently, economically, and ethically.
