RE: Medicaid Policy Updates/Changes

PURPOSE: For ABD, this manual transmittal consists mostly of clarifications to sections on Trust Property, Annuities, and Transfer of Assets in ABD. There were also changes made in the QIT section, and Continuing Care Retirement Communities/Life Care Communities was added to resources in Section 2399. The ineligible child living allowance was updated in Appendix A1, and a new Annuity Issuer Notification form was added in Appendix F, and the PNA amount was changed to \$50 in Appendix I. For Family Medicaid, sections 2054 and 2174 were updated to reflect the policy change which allows children born to EMA mothers to be eligible for Newborn Medicaid. Minor changes were made in the citizenship/alienage section regarding acceptable identity verification. The PeachCare section was updated to reflect new verification requirements and information about CMO enrollment. IN addition, the new Peachcare limits were added to Appendix A2. Minor changes were made in sections 2053, 2661, 2927 and 2940. CMO information was added to Appendix C, and several new terms were added to Appendix E. A revised form 95SP,297A, 297A Sp, and Declaration of Citizenship (form 216) have been added to Appendix F, and workarounds for not verifying citizenship/identity were added to Appendix J. For Children in Placement Medicaid, minor changes were made in Section 2848 regarding case transfers to counties, and in Appendix F the form 227 and form 227 instructions were updated to request information needed for completing a CMD when DFCS is relieved from custody. A note was added to Appendix K that SUCCESS will close F40 and F22 cases where the child receives SSI. Please refer to the chart for specific changes.
